African Financial Alliance on Climate Change: an innovative approach to impact investing and greening of Africa's financial industry

Fifty-one African countries have already ratified the Paris Agreement; the commitments therein, taken together present a US \$3 trillion impact investment opportunity by 2030. Despite this huge market, impact investment in Africa lags behind other regions. Seventy-five percent of the investment is expected to come from the private sector to complement the public sector financing. Mobilizing financial resources for Africa's development will require greening the financial industry and a shift towards future-friendly impact investment.

The session will showcase how innovative initiatives such as the African Development Bank's African Financial Alliance on Climate Change is greening Africa's financial industry and stimulating impact investing in Africa. It will focus on actions and policy measures that should be taken to incentivize sustainable practices, encourage business to develop business models and risk management controls that ensure sustainability in the long term.

Session Room 2**The Co-Guarantee Platform Initiative**

As a result of perceived high risks of investments across the continent and the lack of capacity for traditional lenders to provide risk mitigation products for projects, the African Development Bank in partnership with Africa Export-Import Bank, African Trade Insurance Agency, GuarantCo and the Islamic Corporation for Insurance of Investment and Export Credit created the Co-Guarantee Platform for Africa (CGP), an innovative and collaborative de-risking instrument. Representing the African Union (AU) as the sixth Participant, the AU Development Agency (NEPAD) is the promoter of the African Infrastructure Guarantee Mechanism (AIGM) which will serve as the Platform's infrastructure window. Panelists will provide a deep dive into the utility, importance, and impact of de-risking mechanisms, and explore the opportunities provided by the Co-Guarantee Platform.
